
- 1.00 The Kinjale Large Minor Irrigation Project, Taluka Khed, District Ratnagiri, in Vashishti sub basin of West Flowing River Basin was received for clearance by MWRRA under Section 11 (f) of the Act, vide above Reference.
- 2.00 Vide Hon. Governor's directives for FY 2010-11, there is irrigation backlog in Ratnagiri District. However vide Para 12 of these directives; no new work should be taken up as there are sufficient number of ongoing projects which will take care of the remaining backlog in the district. Therefore there is no need to take up new irrigation projects in this District.
- 3.00 As per Para - 22 and 28 of Hon. Governor's directives for the FY 2010-11, statutory clearance for keeping on shelf can be accorded to the project in Vidarbha region in Godavari basin only. Since this project is in Konkan region in West Flowing River basin, this project is therefore returned herewith.

4.00 District-wise backlog is due for review in 2010. On completion of this review, if the need for new irrigation project in this district is established, this project may be resubmitted to MWRRA with revised techno-economic viability with reference to updated cost along-with the compliance of the remarks annexed herewith for according clearance under Section 11 (f) of the MWRRA Act, 2005 before implementation of this project.
