> Sub: Returning of Par Nadi Large Minor Irrigation (LMI) Project in Nashik District

- 1.00 The Par Nadi Large Minor Irrigation (LMI) Project, Taluka Surgana, District Nashik in Nar-Par sub basin of West Flowing River Basin was received for clearance by MWRRA under Section 11 (f) of the Act, vide above Reference. The proposal has not come through proper channel i.e. from Executive Director, KIDC, Thane or Chief Engineer, Konkan Region, Mumbai.
- 2.00 As per Hon. Governor's directives for FY 2011-12, there is no

irrigation backlog in Nashik District. Hence there is no need to take up new irrigation projects in this District, as irrigation backlog is removed. 3.00 Further as per Para 14 of the same directives, reiterating Paras - 22 and 28 of Hon. Governor's directives for the FY 2010-11, statutory clearance for keeping on shelf can be accorded to the project in Vidarbha region in Godavari basin only. Since this project is in E:\MYDOCS\mydocs\Project Clearance\KIDC\72.docx

Konkan region in West Flowing River basin, the necessity for keeping on shelf does not arise.

- 4.00 However vide Para 9 of the same directives, reiterating Para 14 of Hon. Governor's directives for the FY 2010–11, projects under TSP / OTSP are excluded from the formula prescribed in this directives for removal of backlog. If the project is coming under tribal area, it can be considered for clearance provided it is included under TSP / OTSP by State Government.
- 5.00 You are therefore requested to pursue this with concerned department of State Government to get this project included in TSP / OTSP (presuming it is fulfilling the required norms for such inclusion) and thereafter the project may be resubmitted to MWRRA through proper channel i.e. from Executive Director, KIDC, Thane or Chief Engineer with revised techno-economic viability with reference to updated cost after obtaining clearance from the State Level technical Advisory Committee for according clearance under Section 11 (f) of the MWRRA Act, 2005 before implementation of this project.
