AUTHORITY MEMORANDUM

1.00 Section 11 (f) of the MWRRA Act (Maharashtra Act No. XVIII of 2005) reads as below:

“To review and clear water resources projects proposed at the sub-basin and river basin level to ensure that a proposal is in conformity with Integrated State Water Plan and also with regard to the economic, hydrologic and environmental viability and where relevant, on the State's obligations under Tribunals, Agreements, or Decrees involving interstate Entitlements:

Provided that, while clearing the new water resources projects by the concerned for construction proposed by River Basin Agencies, the Authority shall ensure that Governor's Directives issued from time to time, relating to investment priority for removal of regional imbalance are strictly observed;

Provided further that, in respect of the projects situated in Marathwada and Vidarbha Regions, the powers to accord

administrative approval or revised administrative approval, under this clause, shall in accordance with the Governor's directives, be exercised by the concerned River Basin Agency"

2.00 The project namely Storage Tank at Salbhoye, Tal-Surgana, District Nasik was received for clearance by MWRRA under Section 11(f) of MWRRA Act 2005, vide above references.

3.0 Storage Tank at Salbhoye:-

(i) Storage Tank at Salbhoye is proposed on a tributary of Nar River. The Project lies in Nar-Par Sub-basin of West flowing rivers basin. The Project has been cleared by CE (H.P.), Nasik for water availability of 2.15 Mcum at 50 % dependability. 50 % dependable yield available at the proposed site is 2.83 Mcum. There is no any project on down stream of the proposed project.

(ii) The B.C. ratio is more than 1 for this project.

(iii) This project is within prescribed cost norms in terms of Rs per TCM of Gross Storage.

(iv) This project involves diversion of 1.70 Ha forest land.

(v) Tribal beneficiaries under this project are more than 97 %.

4.0 The irrigation potential created in June 1994 in Nasik District was 33.55% of net sown area and potential created till June 2010 was 49.02% of net sown area which is more than 35.11% the State Average of 1994. Thus Nasik District is not an Irrigation Backlog District. Also there is no financial backlog. As per the Hon. Governor's directives for FY 2011 – 12 no new irrigation projects should be undertaken even in the backlog district. However vide Para 9 of the same directives, reiterating Para - 14 of Hon. Governor's directives for the FY 2010 – 11, projects under TSP / OTSP are excluded from the formula prescribed in this directives for removal of backlog. Accordingly WRD vide its letter no. लपायो-२०११/(४२४/२०११)खारभूमी dated 17-8-2011 has communicated the concurrence of Tribal Development Department for taking this project under TSP. As the Tribal beneficiaries under this project is more than 80%, this project is eligible for 100% funding under TSP as per para 4(1) of Tribal Development Department's GR no. टीएसपी-२००३/प्र.क्र.१०१/का-६ दि. २६/७/२००८.

- 5.00 As per the Project Report, this project involves diversion of forest Land. Forest clearance needs to be obtained from competent Authority.
- 6.00 Environmental clearance is required for this project as per Notification of Ministry of Environment and Forests, Government of India, September 2006. The environmental angle clearance needs to be obtained from Competent Authority as stipulated by MoEF.
- 7.00 The MWRRA is, therefore, pleased to accord Conditional Clearance to Storage Tank at Salbhoye, Tal-Surgana in Nashik District under Sec.11 (f) of the MWRRA Act, as per salient features appended herewith, subject to condition that this project should be fully funded under tribal sub-plan only and should obtain environment and forest clearances before taking up construction work.
- 8.00 This clearance is issued under registered No. 101 and is reference under MWRRA/2010/PRCL/KIDC/46-3MI/876 dated 30/12/2011 in the office of the Authority.
