## Resolution No. 29 Dated February 22, 2019

**WHEREAS**, Executive Director, Godavari Marathwada Irrigation Development Corporation, Aurangabad ("Project Proponent" for short) vide letter dated 16/05/2018 has submitted the proposal of Brahmagavhan Lift Irrigation Scheme - Part III (LIS), Taluka Gangapur, District Aurangabad ("Scheme" for short) for the clearance of Maharashtra Water Resources Regulatory Authority ("Authority" for short) along with the scrutiny note and comments of State Level Technical Advisory Committee for clearance under Section 11(f) of the MWRRA Act, 2005 ("Act" for short);

**AND WHEREAS**, the said LIS is the component of the Jayakwadi Project, meant for giving irrigation benefits to 10000 ha, in drought prone area of Gangapur Taluka of Aurangabad District in Marathwada Region, under the distress farmers mission;

**AND WHEREAS**, 55 Mm<sup>3</sup> water is allotted to the said LIS, as per WRD's GR dated 12/09/2018 - Revised water planning of Jayakwadi Project;

**AND WHEREAS**, the cost, B/C ratio and ERR of said LIS are Rs. 426.26 crore, 1.24 & 17.077 respectively;

**AND WHEREAS**, the Secretary to Hon. Governor vide letter dated 18/12/2018 has given in-principle approval to the said LIS to the extent of obtaining necessary statutory approvals and not for initiation of project;

**AND WHEREAS**, the proposal was scrutinized in light of the provisions in Section 11(f) of the Act for processing the proposal for administrative approval to the extent of obtaining necessary statutory approvals;



**AND WHEREAS**, the said LIS is the component of the Jayakwadi Project which is already included in the Integrated State Water Plan (ISWP) for Godavari basin, approved by the State Water Council in meeting dated November 30, 2017;

**AND WHEREAS**, the total water utilization of the said LIS is 55 Mm<sup>3</sup> and the Authority has ensured that the proposal is hydrologically viable;

**AND WHEREAS**, the Authority has also ensured that the proposal is economically viable with respect to viability norms mentioned in the WRD GR dated 23/11/2016;

**AND WHEREAS**, the Authority has ensured that no interstate aspect is involved in the said proposal;

**AND WHEREAS**, although, as per the mandate of Section 11(f) of the Act, this Authority has to ensure that the proposal is environmentally viable, at this stage the environmental viability cannot be ensured, as administrative approval is prerequisite condition for applying to the competent authority for clearance under Environmental (Protection) Act, 1986;

**NOW, THEREFORE, IT IS HEREBY RESOLVED AS FOLLOWS:**

- a) Having examined the proposal as per the mandate of the provisions in Section 11(f) of the MWRRA Act, 2005, this clearance be given for obtaining the Administrative Approval to the said Brahmagavhan Lift Irrigation Scheme - Part III, Taluka Gangapur, District Aurangabad for financial provisions to the extent of requirements for statutory clearances, preparing detailed designs & drawings and collections of information related to land acquisition.
- b) The Project Proponent be directed to ensure necessary compliance of provisions in Environmental (Protection) Act 1986 and Notification issued by Ministry of Environment and Forest from time to time.
- c) The Project Proponent be directed to obtain separate clearance under Section 11(f) from this Authority after the environmental clearance and prior to physical execution of the said LIS.
- d) This clearance shall be effective from the date of approval of ISWP by the State Water Council with inclusion of Jayakwadi Project in it.
