- 1. The Petitioner for and on behalf of the Rural Local Body Grampanchayat Kanadgaon, Taluka Rahuri, District Ahmednagar having aggrieved by the act of the State Government by which the Kopargaon Nagarpalika and Shirdi Nagarparishad have been added to the earlier sanctioned drinking water supply scheme for Shri. Saibaba Sansthan, Shirdi from Nilwande dam vide G.R. dated September 1, 2017 approached Maharashtra Water Resources Regulatory Authority this Authority ("Authority" for short) on July 13, 2018 in the matter of grievances under Case No. 11 of 2018.
- 2. This Authority was already in receipt of a Petition on behalf of Grampanchayat Pimpri Nirmal, Taluka Rahata District Ahmednagar dated June 27, 2016 under Case No. 7 of 2018 in the above matter. The Authority conducted a hearing on September 6, 2018 & disposed the matter by the Order No. 14/2018 dated October 15, 2018.
- 3. As the prayers in the Case No. 7 of 2018 & Case No. 11 of 2018 are same, this Authority's Order / Directions given in Order No. 14/2018 dated October 15, 2018 passed Case No. 7 of 2018 applies to this Case No. 11 of 2018 and no separate Order needs to be passed as issue is squarely decided now.
