Ref: In the matter of suo-moto action on the Representation preferred by the Petitioner – Govindbaba Water Users Association, Nimbi Tal. Mangrulpir District Washim through its Chairman, Govind Baba Water Users Association, Nimbi Taluka manglurpir District Washim to release water through canal of Minor Irrigation Project Motsavnga Taluka Mangrulpir District Washim for rabbi season 2018-19.

Pursuant to the directions issued by Maharashtra Water Resources Regulatory Authority (MWRRA), established u/s 3 of MWRRA Act, 2005 (herein after referred to as “the Authority”), I am directed to convey you as under:

- (i) Maharashtra Water Resources Regulatory Authority (MWRRA), established u/s 3 of MWRRA Act, 2005 (herein after referred to as “the Authority”) in receipt of the application from Govind Baba Water Users Association, Nimbi Tal. Mangrulpir District Washim through its Chairman, Govind Baba Water Users Association, Nimbi Tal. Mangrulpir District Washim through its representation dated 02.01.2019 has prayed to give direction to Respondents to release water through canal of Minor Irrigation Project Motsavnga Taluka Mangrulpir District Washim for rabbi season 2018-19 and to pay compensation due to losses made in this season, copy of which has been enclosed herewith for perusal, information and ready reference to the Respondent Authorities above named for purpose of filling reply on Affidavit,
- (ii) The Authority having considered the said Representation of the Petitioner and by exercising the powers under Regulation 11 of MWRRA Conduct of Business Regulation, 2013 has now taken the cognizance of the same considering the reasons cited in the said Representation in the beneficiaries interest,
- (iii) The Authority, under the provisions under Section 13 of the Act, prior to taking any decision on the said application, desired to call upon all such relevant information, details and particulars along with documents & records from the Petitioner and Respondent No. 1 to 3 named herein above, such details as specified herein below against the names of the respective Respondents.
  - a) The Petitioner – Chairman – Shri Govind Baba Water Users Association, Nimbi Taluka Manglurpir District Washim: To submit to this Authority copy of any application / documents submitted by him to the Primary Dispute

Resolution Officer Cum Chief Engineer, Water Resources Department, Sinchan Bhavan, Shivaji Nagar, Camp, Amravati under Section 22 (1) of Maharashtra Water Resources Regulatory Act, 2005 and as per Government of Maharashtra, Water Resources Department, GR No.(Marathi) संकिर्ण १००९ /२६५/०९/ सिंव्य धो दिनांक २५ ऑगस्ट, २००९ to resolve disputes with regard to the issuance or delivery of water entitlement (to release water through canal of Minor Irrigation Project, Motsavanga for Rabbi season 2018-19 ) and reply thereon from the Primary Dispute Resolution Officer.


- b) The Respondent No.1 - The Chief Engineer, Specified Project, Water Resource Department, Amravati: To submit copy / copies of any application received from the Petitioner regarding release of water through canal of Minor Irrigation Project Motsavnga Taluka Maglurpir District Washim for Rabbi season 2018-19, action taken thereon and reply given to the Petition.
- c) The Respondent No.2 - The Superintending Engineer, Washim Irrigation Circle, Washim: To submit copy / copies of any application received from the Petitioner regarding release of water through canal of Minor Irrigation Project Motsavnga Taluka Maglurpir District Washim for Rabbi season 2018-19, action taken thereon and reply given to the Petition.
- d) The Respondent No.3 - The Excecutive Engineer, Washim Irrigation division (Construction), Washim: To submit copy / copies of any application received from the Petitioner regarding release of water through canal of Minor Irrigation Project, Motsavnga Taluka Maglurpir District Washim for Rabbi season 2018-19, action taken thereon and reply given to the Petition, copy of which is appended herewith for perusal, information and ready reference. To submit details on Affidavit as regards to the possibility of releasing any water through canal of Minor Irrigation Project, Motsavnga Taluka Mangrupir District Washim to the WUA for Rabbi season year 2018-19
- iv) The Parties / Respondent No. 1 to 3 are further directed to submit the affidavits along with all such relevant information, details and particulars called upon herein above to the extent and concerned for better adjudication of the Representation of the Petitioner trust as early as possible but not later than the date fixed for herein below in the matter.
- v) Next proceeding is fixed for date 7<sup>th</sup> March, 2019 at 3.00 PM in the Authority office.
