## General Guidelines:

- Secretary, MWRRA shall be the SPOC for this empanelment.
- 2 Prior approval of the Chairman, MWRRA and in his absence approval of senior most Member of MWRRA will be taken to decide as to whom this facility should
- i subject to renewal on mutual consent The empanelment agreement with the hotels shall be for a period of 2 years,
- 4 Accommodation of any guest can be upgraded or downgraded depending upon convenience, cost and availability with the prior approval of Chairman - MWRRA
- 5 The hotels shall be of two locations as mentioned below:
- Location A Near the Domestic/International Airport
- Location B Near the MWRRA office Cuffe Parade
- 6 standby depending on quotation submitted by the hotels The empanelment shall consist of two hotels at each location as primary and
- 7. Power to amend/rectify/clarify the guidelines shall be with the Authority
