Terms & conditions of Contract:-

1. The Agency must hold valid licence under provision of Maharashtra Fire Provision & Life measure Rules, 2009.
2. The services provider will have to provide 12 routine services in a year, which will be done by your service team at equal intervals in each month during the year.

3. The routine servicing will cover the following :-
Checking, cleaning, repairing & overhauling of automatic fire Detector system with sprinklers as a whole which is connected with main Fire System of World Trade Centre-1, Ground Floor.
4. The services provider shall attend to the unit for any problem with Fire Alarm System when called upon by us. The complaint shall be attended within 24 hours from the time being reported.
5. The services provider shall undertake repairs of unit or part thereof as overhauling the unit free of charge, if required in your service stations or site when such repairs/ services arises out of normal wear and tear during the contract period.
6. The services provider shall arrange for spares and materials costing up to Rs. 200/- free of charge which may be needed for the unit as a result of normal wear and tear during the contract period. Only major parts like smoke detectors, heat detector, PCB relays, power X mers, powers & condensers, power transistors, rectifiers, speakers with L. M. T. standby batteries, sprinkler pressure switches valves etc. costing more than Rs. 200/- would be paid extra to you.
7. If the Service Providers fails to provide the services to the satisfactory of this Authority the Annual Maintenance Contract shall be terminates forthwith. This contract is for 2 years effective from 01/05/2025 to 30/04/2027.
8. The Service provider will have to quote the rates inclusive of all taxes i.e. total Annual Maintenance charges + G.S.T. and any other tax payable. Applicable taxes shall be deducted at the source.
