



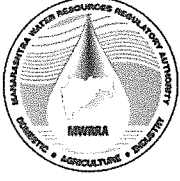

1. This Authority, vide its Order No. 04/2024 dated 16/04/2024, disposed off an Appeal filed by Solapur Municipal Corporation against the Primary Dispute Resolution Officer's Order dated 07/03/2018 for directions to recalculate quantity of water drawn and various penal charges imposed. This Authority, vide Para 39 (xviii) of said Order, directed the Appellant to submit six monthly (half yearly) Compliance Report in an Affidavit Form and the first compliance report of such affidavit to be submitted by 15/07/2024.
2. As the Appellant did not comply above directions even after passage of one and half months, this Authority issued notice under Section 11(b) and 13 (b, c) of MWRRA Act, 2005 dated 05/09/2024 to the Appellant and directed to file an Affidavit within 15 days. Accordingly, Advocate for the Appellant, vide letter dated 19/09/2024, filed an Affidavit in this regard and submitted the status of water pipe line work.

Order

3. After giving due consideration to the said Affidavit of the Appellant, this Authority, hereby orders as under:
 - i. Affidavit taken on record.
 - ii. However, the appropriate steps should be taken by the Appellant to get the requisite permission from the concerned authorities, so



that closed pipeline work is completed within the time. The Appellant should ensure that the work should be completed by Feb-2025 as per affidavit.

- iii. Further compliance affidavit as per said MWRRA order is due in the month of December 2024.
